## Feature Film DVD and Videogame Restriction Request

The Bloomingdale Public Library has been charged with the mission of developing resources to meet the diverse information and entertainment needs of this community; as a result, not all feature films and videogames purchased by the library contain content that is suitable for minors.

The Bloomingdale Public Library maintains that parents and legal guardians have sole responsibility for determining the suitability of library materials for their children. Employees of the library cannot and must not assume the role of parents in the evaluation and/or restriction of individual materials for minor children. The library, however, recognizes that some restrictions may need to be made and provides an option for parents to restrict minor's access to feature films and videogames.

### As the parent or legal guardian: (Please choose one):

- I grant permission for my minor to borrow feature films and videogames, understanding that librarians will not restrict access due to content, MPAA, or ESRB ratings. Further I accept responsibility for all fines and fees accrued while the items are in the minor's possession.
- I do not grant permission for my minor to borrow feature films and videogames.

A minor's access to feature films and videogames is automatically controlled at check out and may be over-ridden by circulation only if the parent or legal guardian accompanies the minor at time of check out. Juvenile and Nonfiction DVDs are not subject to restriction.



## **WARNING** for Internet Access by a Minor

The Internet is an unregulated medium connecting people and information sources from around the world, forming a constantly changing community. Not all sources on the Internet provide information that is current, accurate, unobjectionable or complete. Some materials on the Internet are obscene and/or harmful to minors. The Bloomingdale Public Library is unable to control or monitor the content of materials on the Internet.

The library provides two computer labs with computer access. The Adult Computer Lab is open to patrons of all ages. **The Youth Services Lab is open to patrons ages 16 and under and parents and/or legal guardians accompanying minor children ages 16 and under.**

All computer and Internet use requires a valid Bloomingdale Public Library Card or Internet Use Card.

- Internet access allows the minor patron to use the Internet and other locally installed programs in either the Adult or Youth Services lab. Note: The Youth Services lab is open to patrons ages 16 and under.
- Restricted access **does not allow any Internet access.** Restricted users will only have access to Microsoft Office Suite (Word, Excel, etc.) and locally installed programs.
- Blocked access **does not** allow any COMPUTER ACCESS.

Further, I understand that I am responsible for monitoring my minor child's appropriate use of the Internet Computers.

While the Bloomingdale Public Library attempts to filter content deemed obscene or harmful it is by no means foolproof, and may inadvertently allow content intended to be blocked, or block unobjectionable content.

**I have read and understood the above Warnings and Restrictions and I am aware that there are no age restrictions on borrowing and/or using library materials or equipment beyond the preceding exceptions.**
